But besides these many drug usage monitoring organizations, still we witness people getting arrested for consuming drugs illegally. So now the question rise that whether these monitoring organizations are doing their function properly.

#### LEGAL AND ILLEGAL DRUGS

In India, Cannabis in the form of bhang is not illegal. Other forms like Ganja (marijuana) and Charas (hashish) are illegal in India. Even though the Indian young population is using drugs like marijuana and other illegal drugs and is being arrested by Police officers and by Narcotic officers. #### PENALTY FOR DRUG ABUSE

In India, for a small number of drugs, the punishment is rigorous imprisonment of 6 months and a fine of Rs.10,000 or both. Holding drugs in more than a little quantity but less than a business quantity would result in rigorous imprisonment of 10 years and a fine of Rs.1,00,000. Uttar Pradesh is the leading state in India which is being followed by Punjab and Tamil Nadu.

#### PEOPLE AGAINST ALCOHOL

In the world, many countries are encouraging the production of drugs and supplying them to people as well as exporting those drugs to other countries because the production of drugs plays a major role in the revenue of the countries. Countries get a lot of cost benefits and economic benefits through this drug export and import and thus they encourage the usage of drugs. Alcohol is also a drug. In India, especially in Tamil Nadu, we can witness the sales of alcohol creating records during festival times, and still, a group of people is protesting to close all the **Tasmac shops** that are administered by the state government (poorana madhu vilakku porattam).
