ABSTRACT

"I think we should be brave enough to talk about the things that plague men. Men's vulnerabilities affect men, but they also affect women," Barker said at the Global Men Engage Symposium, a four-day conference to engage men and boys in gender equality¹.

"At the top of the list of burdens is the need for men to provide for their families," he said.

"We found that such economic stress is associated with partner violence, violence against children, and violence against self, such as Barker, whose charity has worked with men and boys in the favelas, or slums, of Rio de Janeiro, Brazil for nearly 20 years, said a recent report on global suicide rates suggesting that men often kill themselves because they don't have a way to express their problems.

More than 800,000 people commit suicide each year. Two-thirds of them are men and three-quarters are from poor or middle-income countries, the World Health Organization (WHO)

said in a September report.²

From a young age, boys and men are expected to behave like "real men," to encourage attitudes and behavior passed from generation to generation, and encourage gender inequality, Barker said.

For example, men who were physically or sexually abused as children or who witnessed violence against women and girls in their families would probably do the same as adults.

Barker said that men who experienced violence as children are two-and-a-half to three times more likely to become violent later in life. Those who have been involved in fights or have been victims of multiple forms of violence are about twice as likely to use violence against a partner.

"I make no apologies for men, but if you care about ending violence against women and girls, you need to care about the violence in men and boys' bodies."

Of course, you want to be accepted by society. So you conform to traditional gender roles, choose a steady job, even if it's boring, pursue acceptable hobbies, and so on. At a time when Women are beginning to appreciate broken gender stereotypes, why do you get little to no support for the same?

WHAT ARE MENS RIGHTS?

Activists say society has become prejudiced and sexist towards men. They also argue that men are discriminated against by the media, the government, and the Supreme Court.³.Men's rights groups are fighting custody laws that favor mothers over fathers, violence against men, false rape accusations, disproportionate prison sentences for men and conscription. supplies for all of their children will prioritize their children's education⁹. Families can also rely on girls' jobs for housework, water transport and childcare, leaving little time for education. But prioritizing girls' education offers perhaps the best return on investment in the developing world. An educated girl is more likely to postpone marriage, raise a smaller family, have healthier children, and send their children to school. She has more opportunities to earn an income and participate in political trials and is less likely to be infected with HIV.

There is abundant political literature that establishes the necessity of universal suffrage for representative democracy. Yet while supporting universal suffrage, James Mill argued that to contain the expense of the representative system, women need not have separate voting rights because their interests were included in those of their husbands and fathers ¹⁰.
